Compliance With Laws

Vendor will comply and will require its agents and employees to comply with all laws, ordinances and regulations adopted or established by the Federal, State, Local Government agencies or bodies, and abide by all facility rules and regulations provided by the Camp Mack. Vendor agrees that all applicable rules, and regulations and request by the duly authorized agents responsible for the public safety and by Camp Mack to assure such safety.

Defacement of Property

Vendor shall not injure, mar, nor in any manner deface said premises or any equipment contained therein; and shall not cause or permit anything to be done whereby premises, property or equipment shall be in any manner injured, marred or defaced.

Clean-up

It is agreed that Vendor will maintain the facility in a clean and safe manner from move-in through move out.

Payment For Damages

Vendor agrees to pay all cost of repair or replacement for any and all damages of whatever, origin, or nature which may have occurred during the term of this Event in order to resort the damaged facility, property and equipment or other part of the premises affected by the event to a condition equal to that at the time of arrival. Vendor also agrees to post damage and cleanup deposit as required by Camp Mack.

Load In and Out

Vendor agrees that all articles, displays and exhibit shall be brought in or out of Camp Mack on at such entranced and such times as designated by Camp Mack Office.

Storage

Vendor assumes all responsibility for all goods, materials, exhibits, displays and articles in or on the premises before, during or after the event.

Removal of Property

Vendor agrees that all materials pertinent to the event which are not the possession of the Camp Mack will be removed from the premises after the Event. Camp Mack shall be authorized to remove, at the expense of the Vendor, all materials remaining in the space. Vendor shall be responsible for payment of storage cost and Vendor agrees Camp Mack shall not be responsible for loss, damage or claims against material removed or stored under this provision.

Complete Agreement

All term and conditions of this Agreement shall be binding upon the parties, their heirs or representatives and assigns, and cannot be waived or modified by any oral representation of promises of any agent or other representative of the parties hereto unless the same be in writing an signed by the duly authorized agent or agents who execute this agreement. Such written document shall be incorporated by specific reference therein as part of this Agreement. Neither party may rely on any oral representation and must look solely to the terms of this Agreement. This agreement constitutes the entire agreement and understanding between the parties, whether oral or in writing, as to the subject matter hereof. Any and all prior agreements, understandings, and representations are hereby terminated and canceled in their entirety and are of no further force or effect. Furthermore, Vendor agrees that notwithstanding eth real possibility of significant damages to Vendor in the event Camp Mack exercises its right of cancellation and the right to retain the deposit and other money, other rights under the Agreement, the Vendor agrees to the terms contained herein and executes the Agreement voluntarily and freely.

Other Conditions

It is mutually agreed that any and all matters not expressly provided for in this agreement be at the sole discretion of Camp Mack.

Public Safety

Camp Mack reserves the unilateral right to cause the interruption of any event in the interests of the public safety and to likewise. The Vendor hereby waives and claim for damages or compensation from Camp Mack. Camp Mack reserves the unilateral right to make such announcements as are deemed necessary at any time in the interest of such public safety. Vendor agrees to cooperate with the delivery of such announcements for public safety, including, but no limited to announcements to require patrons to leave the premises.

CAMP MACK RULES & REGULATIONS

- PLEASE, ABSOLUTELY NO SMOKING IN ANY ROOMS. Cigarette receptacles have been provided outside all rooms for your convenience. If any extra cleaning or deodorizing is required because of any smoke odor in your room, you will be charged accordingly.
- PETS ARE ALLOWED IN DESIGNATED LODGE ROOMS ONLY AND MUST BE MADE AWARE AT BOOKING. The pet fee is \$50 nonrefundable cleaning fee and \$10 per pet per day.
- Pets are welcome in the RV Campground. We Limit to 2 pets of 50 lbs or less at each site. Pets must be kept on a leash at all times & please pick up after them to help keep our park clean. **Pets are not allowed in any of the buildings or rental cabins or houses.**
- The lodge efficiency rooms are supplied with a mini-fridge, sink, coffee maker and microwave for your convenience. This in no way suggests that cooking is allowed. No cookers or hot plates are allowed. If you wish to grill, please use the island areas around the motel driveways, not on the driveways.
- Ice machines are supplied for your personal use in the rooms, not for filling ice chests. Please purchase your ice at the Camp Mack store.
- The fish cleaning station is located near the bait shack at the Camp Mack Outfitter store. This is the only place in the resort that fish may be cleaned.
- The furniture is heavy and built to accommodate the finest and most conformable mattress sets available. Moving the furniture is very difficult for our housekeeping staff. Please do not move any furniture.
- The furnishing and decorations have been placed in your room for your comfort and enjoyment. If you desire to take any of it home with you, applicable replacement charged will be applied to your credit card. Please keep in mind that all rooms are inventoried before and after each guest's use.
- If you lose your room key or you do not return your room key for the Lodge, Houses or Cabins there is a \$50 to rekey fee that will be charged.
- No one under the age of 16 is to operate a motor vehicle or golf cart. You must have a valid driver's license. All-terrain vehicles are NOT allowed to be driven on the property. Please help keep our campground safe by staying to the speed limit of 10-MPH in the Camp.
- Quiet hours in the campground are from 10:00 pm until 7:00 am.
- RV'ers and Campers please do not tie ropes or clotheslines to trees or your RV.
- Only elevated fire pits allowed on the RV site.
- Please place trash in the lattice receptacles. Keep site clean of cigarette butts or bottle caps
- Only 2 vehicles & 1 boat/trailer per RV site. Do not park extra vehicles in empty sites or in open areas. See office for storage of extra vehicles.
- There are no early check-ins for RV pads unless you have arranged with the office and agreed to the early arrival rate.
